# Moor Coach Age

Production of the article on Passaic and Passaic county New Jersey has encountered many roadblocks of late. In the last Newsletter we anticipated that the Fall (Oct-Dec) 2005 issue of NCA would be completed in mid-December, be sent to the printers by the first of January and in the mail by the first of February. But during the first week of March, we find that the issue is still waiting for last minute corrections and additions. Part of the delay can be attributed to the complex map of the area that had to be constructed from scratch, since no comprehensive transit map of the area was ever published. We literally had to draw a new map from the maps of the individual companies that operated in the area. Then there was a breakdown of communicaiton between the ditior and the author-one waiting for questions and the other for input. This problem was finally resolved, and thestory proceeded to page lay-out, followed by the final draft being sent to the author and the corrected draft being sent back to the editor. It is now reported that soon as the editor gets the orrected document back, he will then proceed to make the final changes and send toe issue to the printers for shooting and production of a final version blue line. But all of this time has not been a total waste, as the editor has the content of the Winter 2006 issue ready to go, and has been working on stories for the remainder of the 2006 issues and the first of the 2007 issues

President Bill Vallow will be discussing the Publications problem with the Trustees at their March 31<sup>st</sup> meeting, and will be looking into ways to improve the situation.

# **Spring 2007 Convention**

Arrangements for the hotel for the Spring 2007 Convention in North Carolina were completed and the announcement were completed in early January. After having announcements for the 2006 Conventions sent by first-class mail because of delays to MCA, the Trustees decreed that all future announcements would be included with MCA mailings to avoid the additional expense. At the time, we didn't think that this would be a problem, as it appeared that the 2550 No. 4 issue would be ready for mailing during February. But as the end of February approached we could see that an NCA mailing would not occur in time for sufficient notice for prospective convention attendees.

A hard copy of the announcement is enclosed. Advance copies were sent to those members who are on the Secretary's e-mail mailing list in early January. Any member wishing to be added to this list should contact the Secretary at **glsquier@comcast.net**. The MBS website was updated in February, including the text and form for registration.

Conventions staff is already working on arrangements for the Fall 2007 Convention, which will be in the Columbus-Dayton, Ohioarea during the Columbus day weekend (October 6-8--Sat-Mon).

During this period, the webmaster family faced some severe medical problems, and he was unble to dovote any of his personal time to MBS activities.. Then just at the time these problems were being resolved, he faced a mjor computer hard disk failure, and this was not fixed until after the first of February.

But now the webmaster is back on line, and the site has been updated to include announcements and forms for the Spring 2007 Convention, and the report for the Fall 2005 Convention in Philadelphia. A couple of new features were also added;

## **Vacant Positions**

As mentioned in previous *Newsletters*, in connection with tha 2006 election of Officers, we are soliciting applications from members who are in acting as one of the seven **Regional Vice-Presidents**. In recent years, these positions have been largely dormant, but it is th hope of the new President to get more people involved in MBS activities

The current by-laws of the Society specify that the seven Regional Vice Presidents are nominated by the President and are confirmed by the Board of trustees. Each Regional VP serves a two year term-the same as the appointing President. The seven regions are:

- 1 New England: Main, Vermont, New Hampshire,
- Massachusetts, Rhode Island and Connecticut
- 2 East: New York, New Jersey, Pennsylvania, Ohio, West
- Virginia, Virginia Maryland and Delaware
- 3 Mid-West: Michigan, Indiana, Illinois, Wisconsin,
- Minnesota, Iowa, Missouri, Kansas, Nebraska
- 4 **Pacific Coast:** California, Oregon, Washington, Idaho, Montana, Nevada, Alaska and Hawaii.
- 5 Southwest: Texas, Oklahoma, New Mexico, Arizona, Utah,
- Colorado and Wyoming.
- 6 South: Florida, Georgia, Alabama, Mississippi, Louisiana,

Arkansas, Tennessee, Kentucky, North Carolina and South Carolina

7 Canada and Foreign

The only requirement for these positions is that the member actually live in one of the states in the area he wishes to represent.
